

Notification – Proposed electrical work at Badgerys Creek

Sydney Metro is Australia's biggest public transport project.

RE: Proposed electrical work between the Bringelly Zone Substation and 215 Badgerys Creek Road, Badgerys Creek

Sydney Metro – Western Sydney Airport is the new metro railway line which will service Greater Western Sydney and the new Western Sydney International (Nancy-Bird Walton) Airport.

The railway will service the new airport and airport business park, the Western Sydney Aerotropolis, Luddenham, Orchard Hills and St Marys – here customers can connect to the existing Sydney Trains suburban T1 Western Line. The NSW and Australian governments have a shared objective of having Sydney Metro - Western Sydney Airport operational when the airport opens for passenger services.

Proposed electrical work at Badgerys Creek

Sydney Metro is proposing to extend the existing Endeavour Energy electricity network from the Bringelly Zone Substation to a new switching station at 215 Badgerys Creek Road, Badgerys Creek, to supply temporary power to construction sites for the Sydney Metro – Western Sydney Airport project.

The project is required to notify adjoining landholders under the Electricity Supply Act 1995 and the State Environmental Planning Policy (Infrastructure) 2007.

Work would involve:

- Establishing a new switching station at 215 Badgerys Creek Road, Badgerys Creek
- Installing a new high voltage cable between the Bringelly Zone Substation and the new switching station
- Establishing easements and rights of access to the switching station
- Excavating, trenching and installing underground cables at some locations between the substation and the new switching station.

Construction work and timing

The proposed work will be assessed under Part 5 of the Environmental Planning and Assessment Act 1979 and every effort will be made to minimise disruption to the community.

Subject to approval, installation is scheduled for 2022. We will provide further updates to residents and the community as the project progresses.


