

Notification – Proposed electrical work at 43a Luddenham Road, Orchard Hills

Sydney Metro is Australia's biggest public transport project.

RE: Proposed kiosk substation at 43a Luddenham Road, Orchard Hills

Sydney Metro – Western Sydney Airport is the new metro railway line which will service Greater Western Sydney and the new Western Sydney International (Nancy-Bird Walton) Airport.

The railway will service the new airport and airport business park, the Western Sydney Aerotropolis, Luddenham, Orchard Hills and St Marys – here customers can connect to the existing Sydney Trains suburban T1 Western Line. The NSW and Australian governments have a shared objective of having Sydney Metro - Western Sydney Airport operational when the airport opens for passenger services.

Proposed electrical work at 43a Luddenham Road, Orchard Hills

Sydney Metro is proposing to extend the existing Endeavour Energy electricity network by installing a padmount kiosk substation at 43a Luddenham Road, Orchard Hills, to supply temporary power to construction sites for the Sydney Metro – Western Sydney Airport project.

The project is required to notify adjoining landholders under the Electricity Supply Act 1995 and the State Environmental Planning Policy (Infrastructure) 2007.

Work would involve:

- Establishing a new padmount substation at 43a Luddenham Road, located off Patons Lane, Orchard Hills
- Removing high voltage (HV) overhead cables and two poles
- Installing a new pole to allow for future construction access
- Installing new HV cables on the new and existing poles and the new substation
- Establishing easements and rights of access
- Excavating, trenching and installing an underground cable between new and existing poles and the substation.

Construction work and timing

The proposed work will be assessed under Part 5 of the Environmental Planning and Assessment Act 1979 and every effort will be made to minimise disruption to the community.

Subject to approval, installation is scheduled for 2022. We will provide further updates to residents and the community as the project progresses.

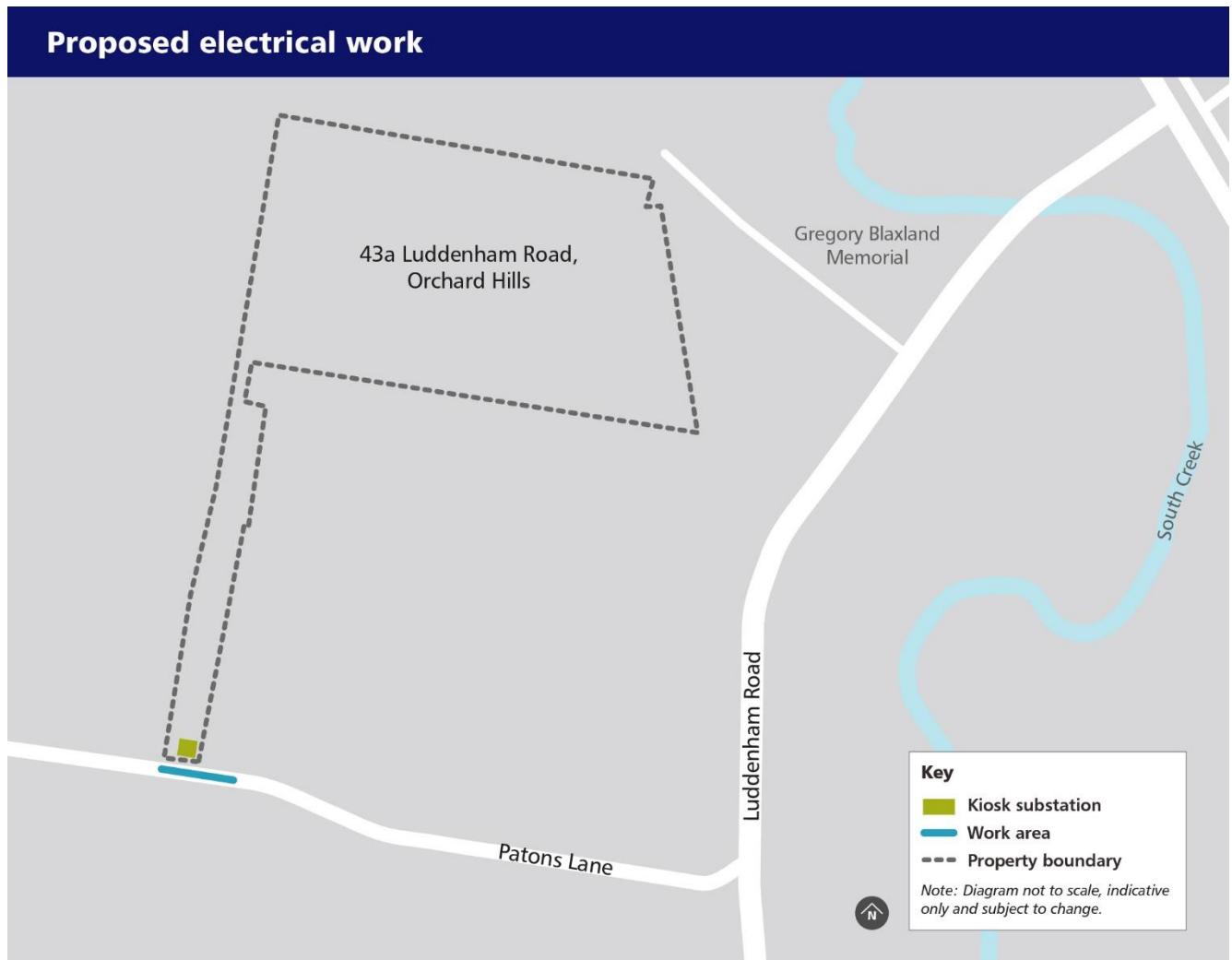
