Noise and vibration issues, incidents, recommendations

Date	Contract / Location and details
10 January	Quickway road restoration, Rozelle. Delivery truck left idling for an extended period and without a driver present. Although not audible beyond about 10m from the truck, Quickway are to remind drivers not to leave vehicles idling – they should be switched off.
19 January	Rock drilling witnessed on 19 January at the eastern end of the Burwood North site during the 11am to 12noon respite period is a non-compliance with AFJV's NVMP, specifically Management Measure MMNV19 in Table 9-1, which states that "high noise-generating activitieswill be carried out in blocks that do not exceed three hours each, with a minimum respite period of one hour between each block." Rock hammering at the site had paused for the respite period, however, rock drilling is included in the Planning Approval definition of Highly Noise Intensive Works and should have ceased too according to the NVMP.
	 The impact of this non-compliance is considered minor, noting that: Condition of Approval D36 requires respite for Highly Noise Intensive Work (only) if it results in an exceedance of the applicable NML (whereas MMNV19 does not include reference to an NML); AFJV measured noise levels of 64dBA at the nearest property boundary during rock drilling alone, which even with the addition of a 5dB penalty as specified in Section 4.2.1 of the Burwood North DNVIS, does not exceed the 75dBA Highly Noise Affected Level in the ICNG, which would appear to be the appropriate NML.
	The AA considers that this was not a non-compliance with CoA D36, based on measured noise levels for the rock drilling and our interpretation of D36. However, it is a non-compliance with Condition C10 which requires that CEMP sub-plans be implemented for the duration of the works. We understand that the NVMP, and possibly the DNVIS, are to be revised to be more consistent with the Conditions of Approval.

Examples of good practice in noise and vibration management		
Date	Contract / Location and details	
10 January	Quickway road restoration Rozelle. Only non-tonal movement alarms heard. Electric hammer drill being used for reo dowel installations. No radios, excessive shouting or other unnecessary noise. Temporary bitumen cover to be excavated had been loosened by hydraulic hammer at intervals along its length to facilitate lifting and removal by excavator. Crew considered to be behaving in a professional, considerate and efficient manner. Noise monitoring of activities observed during inspection.	


	Vibration advised to have been monitored during hydraulic breaking before inspection. Shrouding attached to three sides of hydraulic hammer, to reduce fly rock potential but possibly also reducing noise levels. Small, trailer-mounted vac unit (not in use at the time) observed to have a noise information label.
25 January	Central Tunnelling Package, Sydney Olympic Park, North Strathfield, Burwood, Five Dock. No OOH works in progress, and minor OOH works at The Bays inaudible, consistent with advice provided prior to the inspection.

Noise and vibration complaints
