### Ongoing and upcoming noise and vibration risks

ETP:

- Pyrmont: Cavern excavation continuing 24/7, spoil haulage from Pyrmont East now underway 24/7 (under an EPL variation), TBM tunnelling progressing and cross passage excavation underway.
- Hunter Street: shaft excavation and piling works by day, OOH shed removal and ongoing tunnelling support works at Hunter Street East

CTP:

• Demob and demolition at Five Dock. Managed by comms notifications and consultation.

WTP:


• Acoustic shed demolition, replacement of mains power with generators; relocation of fans and compressors to grout plant location. Being managed by predictive modelling and consideration of noise mitigation measures.
