

Monthly update – Sydney Olympic Park

Sydney Metro West Linewide

April 2026

The NSW Government is delivering Sydney Metro West – a new underground metro railway which will double rail capacity between Parramatta and the Sydney CBD, transforming Sydney for generations to come. Sydney Metro West will target an opening date of 2032.

Sydney Metro has engaged John Holland to deliver the Linewide project. Delivering 60kms of track across the network, installation of rail systems and construction of Sydney Metro West's 38-hectare stabling and maintenance facility in Clyde

What work are we doing?

From **Wednesday 1 April**, John Holland will manage the Sydney Olympic Park metro station site and begin ongoing maintenance and operational activities. Work includes:

- site investigations, including surveying, locating and relocating existing services
- operation and maintenance activities within the construction site and tunnels
- installing access ramps within the station box to the tunnels
- use and maintenance of existing worker facilities
- crane lifting at the station box
- delivery, removal and storing of machinery, equipment and materials.

Equipment and machinery used

Equipment used for this work includes but is not limited to excavators, loaders, dump trucks, compactors, telehandlers, elevated work platforms, forklift, light vehicles and utes, delivery trucks, mobile cranes, street sweepers, bobcats, generators, hand tools and drills. Plant used in the tunnels will include grinders, concrete saws, tunnel transport such as buggies and other materials.

When and where we'll be working

From **1 April to 30 April 2026**, we'll be working within the Sydney Olympic Park metro site between Herb Elliott Avenue and Figtree Drive. All in-tunnel activities will be accessed through the station box within the site.


Standard construction hours are **Monday to Friday from 7am to 6pm and Saturdays from 8am to 6pm**. Tunnel operation and maintenance activities will be undertaken **24 hours per day, seven days a week**. You will be notified in advance of any planned out-of-hours or intrusive works.

What will this mean for you?

You may notice:

- construction workers and vehicles on site
- use of machinery and equipment including cranes and other support activities
- truck and construction vehicle movements via Herb Elliott Avenue, Figtree Avenue, Olympic Boulevard and Australia Avenue
- noise from machinery and equipment
- presence of dust, water and lighting.

Managing our impacts on the community

We aim to manage our work to minimise disruption to the community and the environment. This includes:

- all work will be carried out during standard construction hours
- directing lighting away from properties
- using onsite dust suppression such as water mister attachments, water cannons, wheel washing as required
- designated parking for construction vehicles within the site
- maintaining driveway access for residents and businesses.
