

Project update

April 2021

Sydney Metro is Australia's biggest public transport project.

Services started in May 2019 in the city's North West with a train every four minutes in the peak. Metro rail will be extended into the CBD and beyond to Bankstown in 2024. There will be new CBD metro railway stations at Martin Place, Pitt Street and Barangaroo and new metro platforms at Central.

In 2024, Sydney will have 31 metro railway stations and a 66 kilometre standalone metro railway system. There will be ultimate capacity for a metro train every two minutes in each direction under the Sydney city centre.

Macquarie Group is delivering the new Sydney Metro Martin Place integrated station development and has appointed Lendlease as its design and construction contractor.

Out of hours work around Martin Place

Hoarding adjustments, including relocation of site entry will be required around the Martin Place North site along Elizabeth and Castlereagh streets. Graphics will be installed on the newly built overhead protective hoarding on the South site along Elizabeth and Castlereagh streets. Temporary site accommodation will be constructed on the South site. Waterproofing work will take place within the Martin Place North and South sites.

Hammering work will take place in the adits under the Martin Place North site for the month of April.

The load-out platform removal in the Martin Place North site will also commence in April and will require out of hours work for removal of materials and plant.

Deliveries and removing equipment, machinery and materials will take place out of hours around the Martin Place North, South and Bligh Street sites. Utility work and investigations, including cleaning pits, CCTV investigations, and coring of pavement will take place along Elizabeth, Hunter, Castlereagh, Bligh and O'Connell streets.

Tunnelling work from the South site will take place under 50 Martin Place, 24 hours a day, seven days a week. Out of hour deliveries will also be required for this work.

Work will involve:

- use of an elevated work platform and mobile crane
- minor structural work using hand and power tools
- use of an excavator and road header
- utility work and investigations, including cleaning pits, CCTV investigations and coring of pavement
- delivering and removing equipment, machinery and materials
- temporary partial and full pedestrian footpath closures in some instances with alternate routes provided
- temporary traffic changes including shoulder, parking lane and short-term lane closures.

Work hours

Standard work hours are Monday to Friday, 7am to 6pm and Saturday, 8am to 1pm. Following consultation additional work hours have been approved to take advantage of times when traffic and pedestrian volumes are lower. Extended work hours at the North and Bligh Street sites are **Monday to Saturday, 5am to 10pm**.

Extended work hours at the South site are **Monday to Saturday, 6am to 10pm**.

Out of hours work

Due to high daytime traffic volumes and the need to ensure pedestrian safety, this work will be completed outside of standard construction hours and will occur from **Thursday 1 to Friday 30 April between 8pm and 5am**. Work is expected to take about 20 nights to complete during this time (weather permitting).

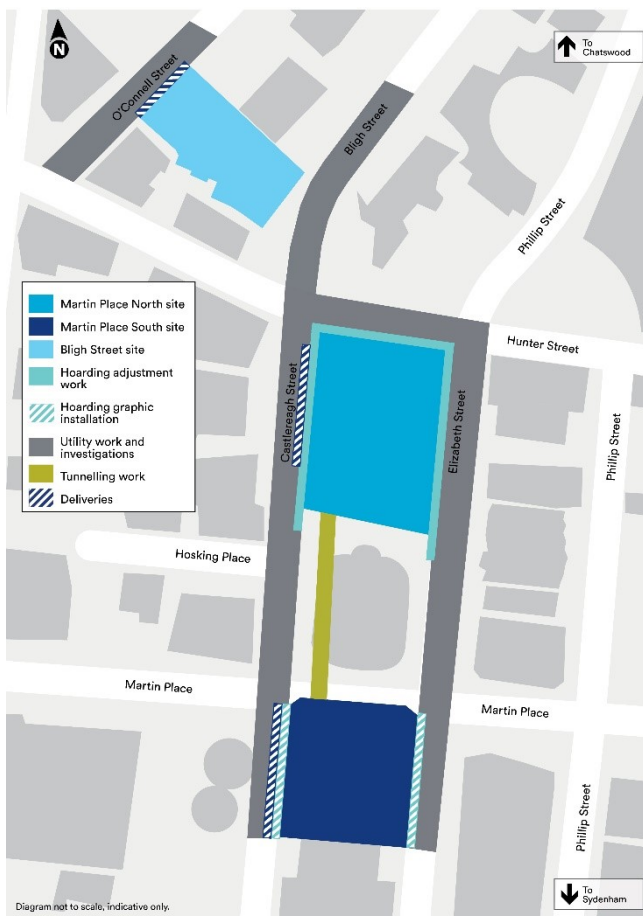
What to expect

- Use of mobile lighting, powered by a generator, will be directed away from residential properties where possible.
- Use of an elevated work platform, hydraulic lifter, mobile cranes, tower crane, truck mounted cranes, and vacuum trucks.
- Equipment used will include excavators with a hammer attachment, road header, utility investigation equipment, bob-saw, concrete saw, wacker packer, tipper and hand tools.
- Some of these activities will be noisy. The project team will limit these impacts wherever possible. Non-tonal reversing beepers will be used and workers will be instructed to keep noise to a minimum.
- Traffic control and directional signage will be in place for the safety of workers and the community.
- Access to buildings and driveways will be maintained at all times.
