

# Notification – Proposed electrical work at Luddenham Road, Luddenham

## 18 March 2021

## Sydney Metro is Australia's biggest public transport project.

### RE: Proposed kiosk substation at 581 Luddenham Road, Luddenham (Lot 4 DP1255721)

Sydney Metro – Western Sydney Airport is the new metro railway line which will service Greater Western Sydney and the new Western Sydney International (Nancy-Bird Walton) Airport.

The railway will service the new airport and airport business park, the Western Sydney Aerotropolis, Luddenham, Orchard Hills and St Marys – here customers can connect to the existing Sydney Trains suburban T1 Western Line. The NSW and Australian governments have a shared objective of having Sydney Metro - Western Sydney Airport operational when the airport opens for passenger services.

## Proposed electrical work at Luddenham Road, Luddenham

Sydney Metro is proposing to extend the existing Endeavour Energy electricity network by installing a padmounted kiosk substation at 581 Luddenham Road, Luddenham (Lot 4 DP1255721), to assist with the development of the Sydney Metro – Western Sydney Airport project.

The project is required to notify adjoining landholders under the Electricity Supply Act 1995 and the State Environmental Planning Policy (Infrastructure) 2007.

Sydney Metro has appointed Ultegra to design and construct this kiosk substation, with the power supplied to the kiosk substation from the existing Endeavour Energy electricity network.

#### Work would involve:

- Establishing the padmounted kiosk substation at 581 Luddenham Road, Luddenham
- Establishing easements and rights of access to the kiosk substation
- Excavating, trenching and installing underground cable from the existing Endeavour Energy electricity network on Luddenham Road to the kiosk substation, to supply 11kV of electricity.

#### **Construction work and timing**

The proposed work will be assessed under Part 5 of the Environmental Planning and Assessment Act 1979 and every effort will be made to minimise disruption to the community.

Subject to approval, installation is scheduled for early 2022. We will provide further updates to residents and the community as the project progresses.
