

Notification – Proposed electrical work from Claremont Meadows to Orchard Hills

11 March 2021

Sydney Metro is Australia's biggest public transport project.

RE: Proposed kiosk substation at 70-74 Kent Road, Orchard Hills (Lot 43 DP 29388)

Sydney Metro – Western Sydney Airport is the new metro railway line which will service Greater Western Sydney and the new Western Sydney International (Nancy-Bird Walton) Airport.

The railway will service the new airport and airport business park, the Western Sydney Aerotropolis, Luddenham, Orchard Hills and St Marys – here customers can connect to the existing Sydney Trains suburban T1 Western Line. The NSW and Australian governments have a shared objective of having Sydney Metro - Western Sydney Airport operational when the airport opens for passenger services.

Proposed electrical work from Claremont Meadows to Orchard Hills

Sydney Metro is proposing to extend the existing Endeavour Energy electricity network from the Claremont Meadows Zone Substation to 70–74 Kent Road, Orchard Hills, to assist with the development of the Sydney Metro – Western Sydney Airport project.

The project is required to notify adjoining landholders under the Electricity Supply Act 1995 and the State Environmental Planning Policy (Infrastructure) 2007.

Sydney Metro has appointed Ultegra to design a kiosk substation at Orchard Hills. The power supply for the kiosk would be brought in from the existing substation at Claremont Meadows.

Work would involve:

- Establishing two high voltage (HV) switching stations at 70-74 Kent Road, Orchard Hills
- Establishing easements and rights of access to the switching stations
- Excavating, trenching and installing an underground cable at some locations between the two switching stations, to supply 11kV of electricity.

Work would be carried out at:

- Sunflower Drive, Gipps Street and Caddens Road, Claremont Meadows
- · Kent Road, Orchard Hills
- M4 Western Motorway

Construction work and timing

The proposed work will be assessed under Part 5 of the Environmental Planning and Assessment Act 1979 and every effort will be made to minimise disruption to the community.

Subject to approval installation is scheduled for 2022. We will provide further updates to residents and the community as the project progresses.


